Your price does not include applicable Ohio sales tax or any local tax, which will be assessed separately, and will not include any fees, taxes or charges directly assessed by your Local Distribution Utility ("LDC") or any other third party with the right to assess taxes or fees for delivery and distribution services (whether passed through to you on utility's bill as a separate line item or as part of the price of natural gas, as required by law, rule or regulation). |

Each month Customer's bill for energy will be calculated by multiplying the Commodity Charges by the amount of energy used in the billing cycle plus applicable taxes. | Renewal | For any Renewal Term, your affirmative consent is not required, even if there is a change in the rate or other terms and conditions. You may terminate at any time during a Renewal Term without any fee or penalty of any kind. |
| Early Termination Fee | No early termination fee. |
| Rescission | Customers have the right to rescind this Agreement by contacting the LDC by phone or United States mail within seven (7) business days following the postmark date on the LDC's confirmation notice. The LDC contact information is listed at the end of these Terms of Service. |
| Sales Method | Eastern Power and Gas LLC is an independent seller of Natural Gas Supply service certified by the Public Utilities Commission of Ohio (PUCO). Our sales agents are not representing or acting on behalf of a utility, governmental bodies, or consumer groups. |
| Delivery | If you purchase natural gas supply from Eastern PNG, your utility remains responsible for delivery of Natural Gas supply to your home or business and will continue to respond to any calls and emergencies. Switching to Eastern Power and Gas LLC will not impact the reliability of your natural gas supply service. |
| Notification | You will receive written notification from your utility confirming a pending switch of your natural gas service to Eastern Power and Gas LLC. |
